Excerpt from the veterinary code of ethics

Article R243-33 - paragraphe 5

Les chiens et chats, préalablement à leur cession, à titre gratuit ou onéreux, sont identifiés par un procédé agréé par le ministre chargé de l'agriculture mis en œuvre par les personnes qu'il habilite à cet effet. Il en est de même, en dehors de toute cession, pour les chiens nés après le 6 janvier 1999 âgés de plus de quatre mois et pour les chats de plus de sept mois nés après le 1er janvier 2012. L'identification est à la charge du cédant.
